## By Using Our Site You Accept These Terms of Use

Please read these Terms of Use carefully and ensure that you understand them before using Our Site. ### 1. Definitions and Interpretation

1.1 In these Terms of Use, unless the context otherwise requires, the following expressions have the following meanings:

“Account” means an account required to access certain features on Our Site, as set out in Part 7;

“Content” means any and all text, images, audio, video, scripts, code, software, databases, and any other form of information capable of being stored on a computer that appears on, or forms part of, Our Site;

“User” means a user of Our Site; “User Content” means Goods for sale, reviews, comments, shared by Users on Our Site; and

“We/Us/Our” means Village Decorations.

- l) is intended or otherwise likely to infringe (or threaten to infringe) another person's right to privacy or otherwise uses their personal information in a way that you do not have a right to;
- m) misleadingly impersonates any person or otherwise misrepresents your identity or affiliation in a way that is calculated to deceive (obvious parodies are not included in this definition provided that they do not breach any of the other content standards in this Part 3);
- n) implies any form of affiliation with Us or any other party where there is none;
- o) infringes, or assists in the infringement of, the intellectual property rights (including, but not limited to, copyright, designs, patents, trade marks, and database rights) belonging to Us or any other party;
- p) is in breach of any legal duty owed to another party including, but not limited to, contractual duties and duties of confidence.

3.3 We may monitor any and all communications made using Our Contact Tools.

3.4 Any personal information sent to Us, whether via Our Contact Tools or otherwise (including, but not limited to, your name and contact details) will be collected, used, and held in accordance with your rights and Our obligations under data protection law, as set out in Our Privacy Policy, available from [www.village-decorations.co.uk](http://www.village-decorations.co.uk)

#### 4. Access to Our Site

4.1 Access to Our Site is free of charge.

4.2 It is your responsibility to make the arrangements necessary in order to access Our Site.

6.2 If any part of the current version of these Terms of Use conflicts with any previous version(s), the current version shall prevail unless We explicitly state otherwise.

#### 7. Accounts

7.8 If you wish to delete your Account, you may do so at any time. If you delete

## 13. Our Liability

13.5 If you are a consumer, you agree that you will not use Our Site for any commercial or business purposes and that We shall have no liability to you for

any business losses as set out above.

#### 14. Viruses, Malware, and Security

14.1 We exercise reasonable skill and care to ensure that Our Site is secure and

free from viruses and malware; however, We do not guarantee that this is the case.

- d) Take further legal action against you, as appropriate;
- e) Disclose such information to law enforcement authorities as required or as We deem reasonably necessary; and/or
- f) Any other actions which We deem reasonably appropriate (and lawful).

15.3 We hereby exclude any and all liability arising out of any actions that We may take (including, but not limited to those set out above in Part 16.3) in response to your breach.

## 16. How We Use Your Personal Information

## 17. Communications from Us

17.1 If We have your contact details and/or if you have an Account, We may send

17.2 We will not send you marketing emails without your express consent. If you do

consent to marketing, you may opt out at any time. All marketing emails from Us include an unsubscribe link.

17.3 For questions or complaints about communications from Us, please contact

## 18. What Happens if We Transfer this Agreement to Another Party

We may transfer (assign) Our obligations and rights under these Terms of Use to a

third party (this may happen, for example, if We sell Our business). If this Occurs, We

will inform you in writing. Your rights under these Terms of Use will not be affected

and Our obligations under these Terms of Use will be transferred to the third party

who will remain bound by them.

## 19. Law and Jurisdiction

19.1 These Terms of Use, and the relationship between you and Us (whether contractual or otherwise) shall be governed by, and construed in accordance with, English law.

19.2 If you are a consumer, you will benefit from any mandatory provisions of the

law in your country of residence. Nothing in Part 20.1 takes away from or reduces your legal rights as a consumer.

19.3 If you are a consumer, any dispute, controversy, proceedings, or claim between you and Us relating to these Terms of Use or to the relationship between you and Us (whether contractual or otherwise) shall be subject to the

jurisdiction of the courts of England, Wales, Scotland, or Northern Ireland, as determined by your residency.

19.4 If you are a business user, any dispute, controversy, proceedings, or claim between you and Us relating to these Terms of Use or to the relationship between you and Us (whether contractual or otherwise) shall be subject to the exclusive jurisdiction of the courts of England and Wales.
